Concerned that level of significance is not demonstrated/ recorded for publicly owned sites, that community perception will be that local government is not subject to the same controls as private sites, and that management category descriptions are inaccurate (eg. Category 4 and 5 having no built features).	Agree – consider revisions to management categories Butter Factory recommended to be on Heritage List	Response provided regarding Old Butter Factory and Category 4 sites. Note benefit of recording level of significance of publicly owned sites on MHI, even though not included on Heritage List. Note improved internal procedures can be considered to provide transparency of process relating to publicly owned sites. Note management category descriptions, to be considered as part of planning policy review. Above items to be considered as part of ongoing heritage review work proposed.	MHI

Retain as level 2: The Clamp's House, a single storey timber and iron cottage has cultural heritage significance for the following reasons: <ul style="list-style-type: none"> • Constructed c. 1870, The Clamp's House is one of a very small number of buildings remaining from the early settlement and development years in Quindalup and as such has some rarity value; • The place is associated with the Clamp family who were early settlers in the district; • The place is an example of an early (c1870) vernacular farmhouse. Modifications can potentially be supported, but demolition is not considered an acceptable outcome.	Assessed in 2012/13 and modification not recommended based on heritage advice and consistent with Council resolution 27/2/2013. 'Slab Cottage' and 'Parkfield' are the only other remaining other examples of 19 th Century residences within the Quindalup and Dunsborough localities with 6 other recorded examples now demolished.
