Sharna Kearney (GBTA)	X		No	<p>The role of the Geographe Bay Tourism Association (GBTA) is to develop, market and manage sustainable tourism for the benefits of its members, the community and visitors. The GBTA are very supportive of initiatives to improve visitor experiences of the region and assist to increase visitation, length of stay and spend. This submission is made by the Association on behalf of its 430 member businesses. Through our contact with more than 300,000 visitors at the Busselton and Dunsborough Visitor Centres annually, we regularly receive negative feedback in relation to the opening hours in Busselton. This was confirmed in "WA Destinations Brand Identity Research" recently undertaken by TNS. The study not only revealed visitor frustration over the early closing hours of many businesses in the region, but also showed it was influencing the choice of accommodation, especially for older visitors who don't want to drive far at night. This is particularly concerning when the concentration of the region's accommodation is in Busselton. The fact that Dunsborough and Margaret River offer lengthier trading hours adds to visitor confusion. The impact this has on visitors experience is perhaps best illustrated by the quote from one of the research subjects below: "We got there quite late and you're walking down the street and bang! 5.30, bang! everything's shut.. where do you go after hours?... days are brilliant - there's not much to do, but at night there's nothing to do." The GBTA strongly supports extended retail trading hours in Busselton on the basis it will improve the visitor experience of the region, in particular Busselton, and assist to increase visitation, length of stay and spend.</p>

Ray McMillan - Busselton Chamber of Commerce and Industry	X		No	<p>The Busselton Chamber of Commerce and Industry has been associated with the discussion of retail trading hours since its inception in 1938. During that time there have been a wide range of perspectives given to this issue and it has been an ongoing debate. We recognise that it is an issue that stirs emotional community interest. The Chamber fully understands the need to have a healthy retail mix of larger and smaller retail operations and this must be considered in the context of a rapidly growing regional economy. Unfortunately, the issue has focussed on that element of the retail sector which employs 18 employees or more and more particularly on the food sector. The busselton retail rector has changed significantly over the past decade with the inclusion now of up to twelve retail businesses that are affected by the legislation (ie. as it relates to business that employ 18 persons or more.) We have moved behyond the limited base of food and vegetable supermarkets to include electrical good retailers and general supermarkets. Most other remain retail businesses are able to open 24/7. It has been noticeable that small retail businesses have been encouraged to take advantage of the extended trading hours approved for the major retailers. This has been particularly applicable for Sunday trading, where retailers have opened at commerically viable times. Busselton operates as a major regional, retail centre and as the primary regional tourist destination in Western Australia, outside Perth. Census statistics for 2011 confirm that position. Busselton is surrounded by neighbouring regional areas where extensive flexibility of trading hours applies, which places our retail opportunities at risk.</p> <p>The situation is as follows:</p> <ul style="list-style-type: none"> * Shire of August-Margaret River can open 24 hours per, for each day of the year; * Shire of Dardanup has the same conditions and is undergoing similar population growth as Busselton; * Denmark, a tourist destination as much as Busselton although the visitor arrivals are much lower, has the same hours as Margaret River; * Shire of Harvey, where there has been significant population growth and the development of new shopping centres, currently operates with 7.00am - 8.00pm Monday to Wednesday and Friday and 7.00am to 9.00pm Thursday and 8.00am to 6.00pm on Saturday and Sunday; * We also have the anomaly with Dunsborough, within the City of Busselton, having had a 8.00am to 9.00pm regime since 1993.

				<p>We have also witnessed the transition in the Perth metropolitan area in very recent times with retail trading hours now 8am - 9pm Monday to Friday; 8am - 5pm Saturday; 11am to 5pm Sunday and Public Holidays and closed on Christmas Day, Good Friday and ANZAC Day. With, in excess of 500,000 tourists visiting the City of Busselton annually, our retail sector is not only accomodating local community expectations and requirement but making a substantial external economic contribution that is witnessed no-where else in Western Australia. Some 86% of tourists who visit us come from Perth and the trend towards greater flexibility of trading hours in the Perth metropolitan area has signficiant influence on customer expectations. Tourists expect to be able to shop in Busselton, when they want to and not be restricted by limited hours.</p> <p>Busselton has been the envy of regional centres throughout Western Australia for some time, with the greater shopping freedom that we have been able to enjoy. We need to continue to accommodate that situation. A report; "The social and Economic Perception and Impact of Rio Tinto's Fly-In-Fly-Out Workforce on the Busselton Community" undertaken by Professor Fiona McKenzie and Dr Aileen Hoath of the Curtin Graduate School of Business, identified that Busselton was not capitalising on the retail spending opportunities that were available due to the leakage to other areas, dictated by retail offerings and apparent restrictive practices. This submission by the Busselton Chamber of Commerce and Industry fully supports the extension of retail trading hours as proposed by the City of Busselton and recommended by the Department of Commerce.</p> <p>These changes will encourage;</p> <ul style="list-style-type: none"> * Greater flexibility for retailers to operate within a time frame that will accommodate both businesses and customers alike; * Retail traders to have the flexibility to operate consistently throughout the year but able to utilise opening times based on commercial decisions. We expect that traders will determine what works best for them; * Busselton, as the major tourist destination in WA to cater for the demands of visitor inflow; * Busselton to be able to operate within comparable times as neighbouring local government authorities. <p>The proposed changes will:</p>
